 3. **Validity of Rate** : Your quoted rate should be valid and firm upto 31st August, 2015 from the date of opening of your offer.
 4. **Delivery Period & Delivery Place** :- Total requirement will be made based on requirement by our site. Delivery to be made at our Chaibasa Project Site, Jharkhand as and when required by our site.
 5. **Payment** :- Within 30 days from the date of delivery and submission of bill with receipted challan.
 6. **Liquidated Damage** :- If you fail to complete supply as per our order within stipulated period, 0.5% of order value will be deducted from your bill for per week of delay subject to maximum of 5% of order value.
 7. **Termination of Contract**:- If the supplier fails to complete the total work/supply/service as per requirement and within the stipulated completion period, BBJ reserves the right to cancel the order, either in part or full as the situation demands and get the work done by deploying other agency/agencies by issuing first seven days and then 48 hours notice. Additional cost if incurred shall be recovered from the supplier's bill.
 8. **JURISDICTION OF COURT**:
The Courts at Kolkata shall have the exclusive jurisdiction to try all disputes, if any, arising out of this agreement between the parties.
