INSTRUCTION TO TENDERER**IB-1**

01. "SUBMISSION OF TENDER" shall be read in conjunction with General Commercial Terms and conditions and any other documents forming part of this Tender Document wherever the context so requires. Notwithstanding the sub-division of the documents into the separate section, every part of each shall be deemed to be supplementary to and complementary to every other part.

02 LANGUAGE

Bids and all accompanying document shall be in English. In case any accompanying documents are in other language, it shall be accompanied by an English translation. The English version shall prevail in matter of interpretation.

02. SUBMISSION OF TENDER :-

- (a) The Tender shall be signed by the person legally authorised to enter into commitment on behalf of the Tenderer.
- (b) All the pages of the tender document to be signed with Company's seal by the Tenderer. The rates in the appropriate space in the **BOQ-1** should be properly filled, both in figures and words. No overwriting, using of correction fluid will be allowed. Any correction will be done by scoring out the incorrect entry and inserting the new entry in a legible manner. Both the correction and new entry to be signed and sealed with Company's seal. In the event of any difference between figure & words of the quoted rates, the rate in word shall be considered for evaluating the tender.
- (c) The tender is to be submitted in a sealed cover and superscribed with Tender Reference, Due Date, marked for the Deputy General Manager(P-V), The Braithwaite Burn And Jessop Construction Company Limited, 27, R. N. Mukherjee Road, Kolkata-700 001 (W.B.). **BBJ shall not be held responsible for postal delay as well as misplacement of bids if the envelope is sealed and superscribed with Tender Reference, Due Date and proper addressee.**

BBJ also reserves the absolute right to split up and award the requirement between two or more Tenderers.
- 06. CURRENCIES OF BID AND PAYMENT:**
The Tenderer shall submit his price bid / offer in Indian Rupees and payment under this contract will be made in Indian Rupees.
- 07.** All duties, taxes, fees and other levies payable by the TRANSPORTER under the contract or any other cause shall be included in the quoted prices.

SPECIAL CONDITION OF CONTRACT**1. DEFINITIONS AND INTERPRETATION:**

2. In this Tender Document, as hereinafter defined, the following words and expressions shall have the meaning as under :
- "**BBJ**" shall mean The Braithwaite Burn And Jessop Construction Company Limited having its Head Office at 27, R. N. Mukherjee Road, Kolkata - 700 001.
 - The "**TENDER**" shall mean the proposal submitted by the Tenderer/Bidder in response to BBJ's Notice of Invitation to this Tender Document.
 - The "**ORDER**" shall mean a written Work Order issued by BBJ.
 - The "**TRANSPORTER**" shall mean the person, firm or Company (hereinafter called Tenderer) whose Tender has been accepted by BBJ.

2. SCOPE OF WORK:

TRANSPORTATION OF STRUCTURAL STEEL PLATES & SECTIONS FROM SAIL, ROURKELA, STEEL PLANT YARD, OR ANY OTHER LOCATION IN ADJOINING AREA WITHIN 30 KM RADIUS TO BBJ MANOHARPUR – BONDAMUNDA SITE, VILL – PARODIH, P.O –JORAIKELA, DIST.- WEST SINGBHUM BESIDE JORAIKELA POLICE STATION. (Detailed as per BOQ-1)

- Qty. variation - \pm 50 %.
- Service Tax to be paid extra.
- VAT/CST/Entry Tax will be borne by BBJ.
- Rate should be quoted per MT basis.
- Minimum tonnage clause is not applicable, unless & otherwise instructed in writing.**
- Payment will be made as per weighment certificate received by BBJ at Site. Bidder has to satisfy themselves regarding routes and availability of weigh Bridge nearly to site for weighment before entering to site for unloading at site. Otherwise payment will be made on the basis of sectional weight or weighment at loading point, whichever is lower.
- Any deviation to the above condition will be treated as cancelled.
- Loading will be done by SAIL stock yard and unloading will be done by BBJ, Site.
- Any incidental charges for lifting at SAIL Plant/ yard/ warehouse and during transportation on road to be borne by the party. Detention charges will not be paid for delay of loading at SAIL, Plant/ yard/ warehouse.
- Appropriate vehicle for lifting of reinforcements to be placed as soon as intimated by SAIL/ BBJ.

- k) Each vehicle should be provided with appropriate communication system for monitoring movement.
- l) The transporter should visit the both point (loading & unloading) to see the road conditions and the materials before quoting their rates.**
- m) Security Deposit: EMD amount of successful bidder will be converted into initial security deposit. Security Deposit @10% of order value may be recovered/ blocked from existing bills, if available or the agency must submit the same before placing order.
- n) Penalty : In case of delayed placement of vehicle for lifting of materials at loading point beyond 48 hours of notification of the same by BBJ through phone/ sms/ email/ fax/ letter (anyone or multimode) or delay beyond the agreed transit period penalty at the rate of Rs 100 per MT per day will be deducted from the bills.

3. FIRM PRICE:

Your rate shall remain firm and shall not attract escalation due to any reason such as diesel price hike whatsoever in pursuance of this contract for a period of six months from the date of order.

4. PAYMENT TERMS: Within 30 days from the date of delivery of the materials with proper document at project site. Quantity given in the BOQ-1 is merely indicative and not guaranteed. **Payment will be made as per weighment certificate received by BBJ at Site.**

5. TRANSIT PERIOD: To be mentioned clearly for only transportation of each trip by Trailer.

6. TIME PERIOD: Twelve months from the date of LOI/Work order.

7. LIQUIDATED DAMAGE:

If the Transporter fails to complete the job within stipulated transit period, 0.5% of order value will be deducted from bill for per week delay subject to a maximum of 5% of the total order value.

8. TERMINATION OF CONTRACT:

In case of failure to discharge the duties as per our requirement, BBJ reserves the right to cancel the order, either in part or full as the situation demands and get the work done by deploying other agency /agencies. Cost incurred for the above shall be recovered from the contractor's bill and Security Deposit.

9. JURISDICTION OF COURT : The Courts at Kolkata shall have the exclusive jurisdiction to try all disputes, if any, arising out of this agreement between the parties.

However, if the delay in transportation is attributable to the transporter L.D. clause as per CL. NO. 7 will be implemented.

11. BBJ reserves the right to distribute BOQ quantity on among different parties. Work in hand of bidders and there past performance will be considered while placing the order.

12. Bidders must indicate (i) the maximum size and capacity of vehicle based on which quotation is submitted and work will be done (ii) ODC Charges over and above quoted price to be indicated separately.
