In this Tender Document, as hereinafter defined, the following words and expressions shall have the meaning as under :

- a) "**BBJ**" shall mean The Braithwaite Burn & Jessop Construction Company Limited having its registered Office at 27, R. N. Mukherjee Road, Kolkata - 700 001.
- b) The "**TENDER**" shall mean the proposal submitted by the Tenderer/ Bidder in response to BBJ's Notice of Invitation to this Tender Document.
- c) The "**ORDER**" shall mean a written Work Order issued by BBJ.
- d) The "**TRANSPORTER**" shall mean the person, firm or Company (hereinafter called Tenderer) whose Tender has been accepted by BBJ.

**2. SCOPE OF WORK:**

***Transportation of Plants/Tools/tackles/resources, trestles, CGI Sheet etc. from Chaibasa ROB Site, Jharkhand to Heavy Plant Yard, Kolkata***

By Truck (16 MT Capacity) - 192 MT.

By Trailer (22 MT Capacity) - 110 MT.

( Detailed as per BOQ-1).

- a) Qty. variation -  $\pm 20\%$ .
- b) Service Tax to be paid extra as per rule applicable.
- c) Rate should be quoted per MT basis.
- d) Minimum tonnage for Trailer – 22 MT and for Truck – 16 MT Capacity.
- e) Any deviation of the above quotation will be treated as cancelled.
- g) Loading and unloading will be done by BBJ.
- h) Detention charges will not be paid for delay of loading.
- i) The transporter should visit the both point (loading & unloading) to see the road conditions and the materials before quoting their rates.

**4. PAYMENT TERMS:**

Within 30 days from delivery of the materials with proper document.

**5. TRANSIT PERIOD :**

To be mentioned clearly for only transportation of each trip by Trailer & Truck.

**6. TIME PERIOD :**

Twelve months from the date of Work order/LOI.

**7. LIQUIDATED DAMAGE:**

If the Transporter fails to complete the job within stipulated transit period, 0.5% of order value will be deducted from bill for per week delay subject to a maximum of 5% of the total order value.

**8. TERMINATION OF CONTRACT:**

In case of failure to discharge the duties as per our requirement, BBJ reserves the right to cancel the order, either in part or full as the situation demands and get the work done by deploying other agency /agencies. Cost incurred for the above shall be recovered from the contractor's bill and Security Deposit.

**9. JURISDICTION OF COURT:**

The Courts at Kolkata shall have the exclusive jurisdiction to try all disputes, if any, arising out of this agreement between the parties.

**10. TRANSIT INSURANCE**

Transit insurance of equivalent amount will be taken by the transporter.
