5. **Delivery Period**: - Within **15 days** from the date of LOI/Order, whichever is earlier.
6. **Payment** :- Within 30 days from the date of delivery and submission of bill with receipted challan.
7. **Liquidated Damage** :- If you fail to complete supply as per our order within stipulated period, 0.5% of order value will be deducted from your bill for per week of delay subject to maximum of 5% of order value.
