BBJ reserves the right to cancel or accept or reject any or all tender(s), whether lowest or otherwise, without assigning any reason(s), whatsoever thereof. A tenderer whose Tender is not accepted shall not be entitled to claim any cost, charges or expenses incidental to or incurred by him through or in connection with the preparation and submission of the Tender/Offer to BBJ. BBJ also reserves the absolute right to split up and award the requirement between two or more Tenderers.
2. **Rate** :- Your quoted rate should be inclusive of all taxes and duties and delivery charges. Particular "**make/brand**" to be mentioned in the offer, otherwise no offer will be considered against the said NIT. Entry Tax will be borne by BBJ.
3. **Validity of Rate** : Your quoted rate should be valid and firm for a period of 3(three) months from the date of opening of your offer.
4. **Delivery at** :- Ganga Bridge Site,Munger(Bihar).
5. **Delivery Period**: - Within 30 days from the date of LOI/ORDER.
6. **Payment** :- Within 30 days from the date of delivery and submission of bill with receipted challan.
7. **Earnest Money Deposit** :- An amount of **Rs.5,000.00**(Rupees five thousand only) to be submitted with individual offer, as EMD amount in form of account payee Demand Draft/Pay Order/Banker's Cheque in favour of "The Braithwaite Burn And Jessop Construction Company Limited", payable at Kolkata. Unsuccessful bidders will be refunded the Earnest Money Deposit amount after the award of the contract/order to the successful bidder.
