- 2. **Rate :-** Your quoted rate should be inclusive of all taxes and duties and delivery charges up to our Ganga Bridge Site,Munger(Bihar). Entry Tax, if any, will be borne by BBJ.
- 3. **Validity of Rate :** Your quoted rate should be valid and firm for a period of 90 days from the date of opening of offer.
- 4. **Delivery at :-** BBJ Ganga Bridge Site,Munger(Bihar).
- 5. **Delivery Quantity and Delivery Period: - Phase-I:- 25(twenty five) nos.** to be delivered **within 15 days** from the date of LOI/Order alongwith Manufacturer's Test Certificate and Guarantee & Warranty Certificate. **Phase-II:- Balance 35(thirty five) nos.** will be required as per site's requirement after delivery of Phase-I.

6. **Earnest Money Deposit** :- An amount of **Rs.5,000.00**(Rupees five thousand only) to be submitted with individual offer, as EMD amount in form of crossed **Demand Draft/Pay Order/Banker's Cheque** in favour of "**The Braithwaite Burn And Jessop Construction Company Limited**", payable at Kolkata. 9. **Liquidated Damage** :- If you fail to complete supply as per our order within stipulated period, 0.5% of order value will be deducted from your bill for per week of delay subject to maximum of 5% of order value.
10. **Termination of Contract**:- If the supplier failure to complete the total work/supply/service as per requirement and within the stipulated completion period, BBJ reserves the right to cancel the order, either in part or full as the situation demands and get the work done by deploying other agency/agencies by issuing first seven days and then 48 hours notice. Additional cost if incurred shall be recovered from the supplier's bill.
