1. **Item required** :-

(a). HSS Taper Shank Drill Bit- 23.5mm dia (Make:- "Addison"/"IT")

(b). HSS Taper Shank Drill Bit-25.5mm dia (Make:- "Addison"/"IT")

BBJ also reserves the absolute right to split up and award the requirement between two or more Tenderers.
- **Except "ADDISON"/"IT" make, no other brand/make is acceptable against this NIT.**
- **Following documents to be submitted by each bidder with their Bid positively.**
  - (a). Copy of valid Trade Licence;
  - (b). Copy of GST Registration Certificate;
  - (c). Copy of PAN Card.
  - (d). Authorised dealer/stockist should submit the copy of their valid Authorisation Certificate(**in original**)/Copy of their valid Dealership Certificate alongwith above documents.
- 2. **Rate** :- The vendors must submit their offer **strictly as per Bill of Quantities (BOQ-1)** of this tender document. The bidder must quote **the Basic Price/Unit Price, GST and Delivery Charges** (up to Heavy Plant yard,Kolkata). The price must be firm during the tenure of this supply / contract & no escalation on any account will be allowed. Entry Tax, if any, will be borne by BBJ.
- 3. **Validity of Offer** : Your offer should be valid and firm for a period of 90 days from the date of opening of offer.

4. **Delivery Place** :- At BBJ Heavy Plant Yard, P-82 Taratala Road,Garden Reach,Kolkata-700 024 with Manufacturer's Test Certificate and Guarantee & Warranty Certificate.
5. **Delivery Period**: - Within 07 days from the date of LOI/Order, whichever is earlier.
6. **Payment** :- Within 30 days from the date of delivery and submission of bill with receipted challan alongwith Manufacturer's Test Certificate and Guarantee & Warranty Certificate.
7. **Liquidated Damage** :- If you fail to complete supply as per our order within stipulated period, 0.5% of order value will be deducted from your bill for per week of delay subject to maximum of 5% of order value.
8. **Termination of Contract**:- If the supplier failure to complete the total work/supply/service as per requirement and within the stipulated completion period, BBJ reserves the right to cancel the order, either in part or full as the situation demands and get the work done by deploying other agency/agencies by issuing first seven days and then 48 hours notice. Additional cost if incurred shall be recovered from the supplier's bill.

The Courts at Kolkata shall have the exclusive jurisdiction to try all disputes,if any, arising out of this agreement between the parties.
