1.0 Following clauses are hereby amended and shall be read as under;

2.	Cl. No. 14(b) (ii): Free issue and Reconciliation of raw steel:	The fabricator shall prepare reconciliation statement based on cutting plan and materials issued. Overall wastage including irrecoverable wastage should be limited to 4% of the overall tonnage of fabrication work. Scrap and offcuts should be return at the designated place at the fabrication workshop.	The fabricator shall prepare a reconciliation statement based on the cutting plan and materials issued. Overall wastage including irrecoverable wastage should be limited to 4% of the overall tonnage of fabrication work and as per certification of BBJ's engineer. Scrap and offcuts should be returned at the designated place at the fabrication workshop.
3.	Cl. No. 15(c): Other Scope of supply by BBJ: Cl.15 c	BBJ will provide crane facility and compressed air if required as per availability of the same.	BBJ will provide crane facility and compressed air if required and allocation of the same will be decided by BBJ's engineer.

2.0 General Clause

- a) For trial assembly of the fabricated girder, BBJ will provide necessary civil foundations at one location which will be shared by all the agencies and BBJ.
- b) Statutory fees if any will be paid by BBJ in respect of inspection fees of RDSO and or any other inspection agency.
