2.0 Scope of Work

a) Eligibility Criteria:

1. Experience in similar nature of work (Technical Capacity);

As proof of possessing the Experience in similar nature of work for carrying out the proposed work, bidder should possess the experience of having successfully completed / substantially completed similar works during the last 7 years (ending last day of the month previous to the one in which tenders are invited), which should be any one of the following:-

- (i) One similar work costing not less than the amount equal to 60% of the advertised Cost of the work, or
- (ii) Two similar works costing not less than the amount equal to 40% of the advertised Cost of the work, or
- (iii) Three similar works costing not less than the amount equal to 30% of the advertised Cost of the work.

- c) These items of work should have been executed during the previous 7 financial years, i.e. 2012-13, 2013-14, 2014-15, 2015-16, 2016-17, 2017-18, and 2018 2019 and up to the submission of the bid in the current FY. Proof of executed item of work shall be sought from employer and shall

be certified by employer.

2. Bid Capacity;

In case of JV, the arithmetic sum of individual "Net worth" of all the members shall be taken as JV's "Net Worth" to satisfy this requirement.

4. Annual turnover;

As a proof of possessing the financial capability of executing the proposed work, the cumulative annual turnover during last three (03) years should be at least 150% of Estimated / advertised cost.

Authentic Certificates shall be produced by the tenderer(s) to this effect which may be an attested Certificate from the employer/ client, Audited Balance Sheet duly certified by the Chartered Accountant etc.

Note: Certificate from private individuals/ firms for whom such works are executed / being executed shall not be considered.
