4. Delivery schedule :

- a) Within 30 days from the date of LOI/Order whichever is earlier or as per requirement by our site time to time.
- b) Delivery to be made at our Ganga Bridge Site,Munger(Bihar).

5. RATE :

a)The vendors must submit their offer strictly as per Bill of Quantities BOQ-1 of this tender document.
