2. **Rate** :- Your quoted rate should be inclusive of all taxes & duties and delivery charges up to our Heavy Plant Yard,Kolkata. Entry Tax, if any,will be borne by BBJ.

Manufacturer's authorized dealer(s) is/are only eligible to submit their offer against this NIT. Manufacturer's authorised dealer should submit their valid dealership certificate of ESAB India Limited, copy of dealer's PAN card, copy of dealer's VAT Registration Certificate at the time of submission of their offer, otherwise no offer will be entertained by BBJ against this NIT.
